Additional Information

The suspect, Joshua Logan Holdman, is a registered sexual offender with the State of Florida. He was convicted of the Use of the Internet to Solicit/Attempt to Solicit etc a Child for Sex/Lewdness on 05/22/1997 in Jacksonville, Duval County, Florida. As such, he is required to register with the Florida Department of Law Enforcement (FDLE) and the Jacksonville Sheriff's Office every six months, during the months of January and July. In addition, the suspect is required to abide by all FDLE Sexual Offender Obligations outlined in F.S. 943.0435, 944.607 or 985.4815.

The suspect last reported to the Jacksonville Sheriff's Office Felony Registration Unit on 08/13/19 to complete update his FDLE Sexual Offender registration with a Logistics Officer. Upon completion of his registration, the suspect electronically signed the

registration, acknowledging that he understood his FDLE Sexual Offender Rules/Requirements.

Detective T. Calderon #7737 was contacted by Special Agent Ben Luedke of Homeland Security via phone during the week of December 1st. He advised Homeland Security was conducting an investigation of Child Porn involving Joshua Holdman and asked if suspect Holdman had a KiK account registered on the Florida Department of Law Enforcement Sexual Offender/Predator Data base. Detective Calderon advised suspect Holdman did not have a KiK registered. Special Agent Luedke advised the hits on the KIK account came back to the IP address at the suspect's permanent registered address (2140 Ashland Street).

On 12/16/19 Sergeant C. Bear #5728 received an email from Special Agent Ben Luedke advising they would be executing a search warrant on the residence of Joshua Holdman's residence located at 2140 Ashland Street, Jacksonville, FL 32207.

On 12/17/19 at approximately 0630, a search warrant was executed by Homeland Security at suspect Holdman's residence at 2140 Ashland Street. After the warrant was executed, I observed a Christmas Tree in the front window of the suspect's residence in clear view from the street. The suspect is in violation of Municipal Ordinance 685.104 which states: Any person designated a Sexual Offender/Predator shall not place or allow any display, including but not limited to displays for any nationally or locally recognized holiday or seasonal event or practice, to be visible from the exterior of any Sexual Offender's or Sexual Predator's residence, including a vehicle or vessel, or on any property which is leased, rented, owned or occupied by such person, if such display is primarily targeted to entice, attract, or lure a child onto any residence or property, or onto or nearer to any vehicle or vessel rented, owned or occupied by such person. Enforcement of this section shall not be limited to the actual calendar date of any given nationally or locally recognized holiday or seasonal event or practice.

During the course of the interview with Special Agent Luedke, the suspect admitted to having a KiK account and a Grindr account. The suspect advised he was unable to recall his user names for each account. Special Agent Luedke showed him the user name for Kik (lilbrucew_2oj) and the suspect did not deny that it was his account. He advised he created the KiK account six months ago and is still active.

I asked the suspect if he was advised of his Miranda Rights by the Homeland Security. He advised he was. I asked if he had any questions about those right and if he want me to read him his rights again. The suspect advised he understood his rights and did not need me to advise him of his rights again. He the agreed to speak with me. The offender admitted he "used to have" a KiK account but did not recall his user name. He advised he created the KiK account six months ago and it is still active.

Homeland Security searched the suspect's phone and found the suspect also had Facebook, Skype, and Yammer (a social network communication APP). He admitted to messaging with his boss using Yammer and understands it's a messaging sites and he should have registered it and it was an "oversight" that he did not register it. He denied having a Facebook or Skype account.

The suspect, Joshua Holdman failed to report his KiK and Yammer account (internet sites or associated page identifiers) with the Florida Department of Law Enforcement or the Jacksonville Sheriff's Office within 48 Hours of Use. His failure to report the internet sites is in violation of rule # 4 of his registration which states:

Within 48 hours after using any electronic mail address or Internet identifier, I MUST report it using the online system maintained by the Florida Department of Law Enforcement or in person at the sheriff's office. OR, if I am on supervision with the Florida DOC or DJJ, this information MUST be reported to my probation officer before using such electronic mail addresses or Internet identifiers. {F.S.943.0435(4)(e)1.; 775.21(6)(g)5.a.} FAILURE TO REPORT THIS INFORMATION AS REQUIRED IS A THIRD DEGREE FELONY.

When the suspect completed his registration on 08/13/2019, he failed to report KiK and Yammer social media sites. At the completion of his registration, the suspect signed the form advising the information he provided was true and correct. The suspect is in violation of Rule 22 which states:

22. KNOWINGLY PROVIDING FALSE REGISTRATION INFORMATION BY ACT OR OMISSION IS A THIRD DEGREE FELONY.{F.S. 943.0435(14)(c)4.; 775.21(10)(a)}.

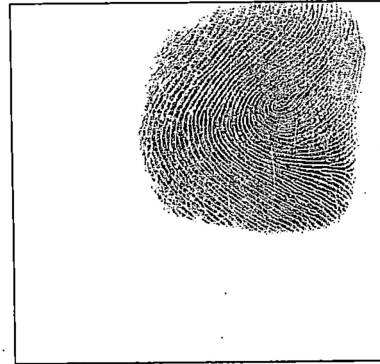
