Additional Information

On 12-01-19, I was assigned to conduct an address verification on the listed suspect, Michael Anthony Scott. The suspect is a registered sex offender under Florida Law. On 11-09-00, the suspect was adjudicated guilty for the sex offense of lewd, lascivious Child U/16 F.S. 800.04 in Duval, FL.

On 12-09-19, I traveled to 9148 Castle Blvd in an attempt to meet with the listed suspect. Upon my arrival, I was unsuccessful in my efforts, but did make contact with a current resident, Ms. Fostine Randolph. She advised that the listed suspect was not present. I provided Ms. Randolph with my contact information. As I continued to converse with Ms. Randolph, I observed the listed vehicle in the driveway of the residence. I conducted a check via Florida Department of Law Enforcement (FDLE) sex offender database which revealed that the suspect did not have the listed vehicle registered on file. I ran the tag (LXTD07) via D.A.V.I.D which revealed that the vehicle's registered owner is Fostine Elps Randolph. She advised that she has had the listed vehicle registered to her address for over a month. Ms. Randolph advised that she has resided at 9148 Castle Blvd for over 50 years. The suspect currently has the address of 9148 Castle Blvd registered as his permanent address with FDLE.

On 12-18-19, I traveled again to 9148 Castle Blvd. Upon my arrival, I immediately noticed that the residence had been decorated with numerous Christmas decorations. The residence had 18 plastic candy canes and 4 red bows on the front gate as well as two wreaths on the two posts of the carport. I was able to successfully make contact with the listed suspect. I advised him of his Miranda Rights and the nature of the above listed charges. Post Miranda, the suspect

The suspect is in violation of Florida State Statue F.S. 943.0435(2)(b)3 of his sex offender rules which states:

**I MUST report any changes in vehicles owned within 48 hours in person at the sheriff's office.
FAILURE TO REPORT THIS INFORMATION WITHIN 48 HOURS IS A THIRD DEGREE FELONY.**

FDLE defines that vehicle owned means any motor vehicle in 320.01 which is registered, co registered, leased, titled, or rented by me, a rented vehicle that I am authorized to drive; or a vehicle for which I am insured as a driver. The term also included any motor vehicle as defined in 320.01 which is registered, co registered, leased, titled, or rented by a person or persons residing at my permanent residence for 5 or more consecutive days.

The suspect is also in violation of Jacksonville Municipal Ordinance 685.104 which states:

(1) It is unlawful for any Sexual Offender or Sexual Predator to participate in any practice or event, including, but not limited to, any event related to a nationally or locally recognized holiday or seasonal event, if such practice or event is primarily targeted toward non-familial children.

(2) It is unlawful for any Sexual Offender or Sexual Predator to wear costumes, clothing, make-up, mask or anything that would alter a person's appearance in the presence of any non-familial child if such altered appearance could or would entice, attract or lure a child to congregate around, or move closer to, that person.

(3) Any person designated a Sexual Offender or Sexual Predator shall:

Not place or allow any display, including but not limited to displays for any nationally or locally recognized holiday or seasonal event or practice, to be visible from the exterior of any Sexual Offender's or Sexual Predator's residence, including a vehicle or vessel, or on any property which is leased, rented, owned or occupied by such person, if such display is primarily targeted to entice, attract, or lure a child onto any residence or property, or onto or nearer to any vehicle or vessel rented, owned or occupied by such person. Enforcement of this section shall not be limited to the actual calendar date of any given nationally or locally recognized holiday or seasonal event or practice.

The violation was photographed.

A search incident to arrest revealed that the suspect had the listed property in his wallet. The property was placed in the property room. A conducted a search via master name index which revealed negative reports for the listed property being stolen or associated with a victim.

The suspect was arrested, transported, and placed in jail.

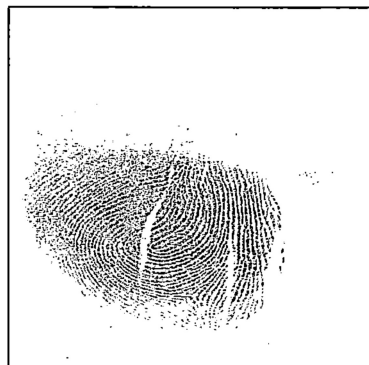
